Exchange Fee – One-time deposit and withdrawal fee in EUR. It shall cover the costs associated with the conversion to virtual currencies or cash (FIAT).

Portfolio Fee p.a. - The annual fee for the provision of consulting services related to the management and algorithmic optimization portfolio, which follows movements of the cryptocurrency market. The Portfolio Fee is an annual fee charged in advance for one year of the first deposit and for each subsequent deposit, an aliquot amount on the anniversary date of the first deposit.

Renewal of the portfolio fee - is carried out on the anniversary of the first deposit and the current value of the portfolio is considered as a deposit according to this price list. The fee includes the cost of rebalancing the portfolio for the entire next year.

Success Fee – Is paid in case of withdrawal and only from the user's profit. The basis for calculating the success fee from the profit on withdrawal or transfer is the profit of the user at the time of withdrawal or transfer. In the case of partial withdrawal, the basis for calculating the success fee is either the amount of the partial withdrawal or the amount of the profit, the lower amount shall apply. In case of loss, this fee is not paid.

The fee for providing custody services is paid annually and is paid in advance and from each deposit aliquot to the anniversary date of the first deposit.

Renewal of the custody fee - is carried out on the anniversary of the first deposit and the current value of the virtual currencies is considered as a deposit according to this price list. The fee includes the custody cost for the entire next year.

Other fees

Instant deposit account authorization fee - € 0.30 - fee for verification of bank account ownership or right of disposal.

Instant deposit fee - 2.9% addition to the deposited amount. One-time fee for using the instant deposit feature. This fee is charged in addition to other deposit fees.

Transfer Fee – 0.75 % is paid for the conversion of virtual currencies from the Fumbi Index Portfolio into a single virtual currency (BTC or ETH). It is paid from the total value of other virtual currencies.
