PROCESS OF THE AUDIT:

Upon the client's request item A.) an independent audit of wallets in custody of Fumbi Network J. S. A. (further on referred to as a "Client") was performed.

IN COURSE OF THE AUDIT, THE BALANCE OF CRYPTOCURRENCIES IN INDIVIDUAL WALLETS IN THE PRODUCTION DATABASE WAS COMPARED WITH THEIR CURRENT VALUES IN INDIVIDUAL STORAGE SOLUTIONS.

THE BALANCE OF THE AUDITED CRYPTOCURRENCIES IN INDIVIDUAL WALLETS WAS SUBMITTED BY THE CLIENT AS AN EXPORT FROM THE PRODUCTION DATABASE CREATED ON JULY 20TH, 2023 AT 9:16 AM.

THE EXPORT ITSELF CONTAINED BALANCES OF A TOTAL OF 56 CRYPTOCURRENCIES, TOGETHER WITH THEIR CURRENT RESPECTIVE EXCHANGE RATES, THE SUMS OF INDIVIDUAL CRYPTOCURRENCIES CONVERTED TO EUR AND THE ACCOUNT IDENTIFIERS ON INDIVIDUAL STORAGE SOLUTIONS.

SURPLUSES ARE CAUSED BY ROUNDING IN THE ACCOUNTING SYSTEM.

IN ADDITION, THE DISPOSAL OF ALL 56 CRYPTOCURRENCIES BY THE CLIENT HAS BEEN PROVEN.
